I. CALL TO ORDER AND PLEDGE OF ALLEGIANCE

II. PUBLIC COMMENTS

The floor was open for public comments.

 HTA (Highland Teacher's Association) member Steve Masson, Tom Truscello, Kelly Nelson, Heather Bragg, Chris Sgro, Jim Moriarty and Dana McGrath spoke on various educational electives and curricular programs which have demonstrated a positive educational environment in the school. There were an approximate 61 HTA members that supported their statements and requested the Board of Education to seriously consider proposing a budget that would allow these programs to remain intact.

 Holly Brooker, parent, supported the Board in proposing a school budget to keep the current educational and elective programs in place, even if it would require a 60% majority vote.

III. BUSINESS AND OPERATIONS

i. <u>Budget Discussion for the 2016-2017 School Year</u>

Business Administrator Louise Lynch and Superintendent Deborah Haab presented three proposed budget scenarios for the 2016-2017 school year.

Scenario 1:

Total Budget: \$41,522,885

Budget Increase Percentage: 2.50% Levy Increase Percentage: 0.59%

True Tax Rate Annual Increase: \$100K / \$13

\$200K / \$26 \$300K / \$39

Scenario 2:

Total Budget: \$41,656,096

Budget Increase Percentage: 2.83% Levy Increase Percentage: 1.77%

True Tax Rate Annual Increase: \$100K / \$39

\$200K / \$52 \$300K / \$65

Scenario 3:

Total Budget: \$41,656,096

Budget Increase Percentage: 2.83% Levy Increase Percentage: 2.00%

True Tax Rate Annual Increase: \$100K / \$45

\$200K / \$58 \$300K / \$71

Further discussion on budget and various budget proposals took place.

Based on the April 22nd deadline for a proposed budget to be in place, Alan Barone requested the Board to share their thoughts on scenario 3 (levy increase of 2% - piercing the tax cap and requiring a majority vote of 60%).

BE IT RESOLVED that the Board of Education, upon the recommendation of the Superintendent of Schools, approves adopting the General Fund Budget for the 2016-2017 school year in the amount of \$41,719,868, as presented at the April 12, 2016 Board of Education Meeting. (Please note this budget amount was rescinded at the April 20th meeting. Budget amount should reflect \$41,656,096.).
