Opening Comments:

Alan Barone thanked community for casting their votes at the last budget vote. Unfortunately, it was a disappointment that the budget did not pass due to a required 60% supermajority approval.

II. PUBLIC COMMENTS

III. BOARD OF EDUCATION

i. <u>Budget Discussion for the 2016-2017 School Year</u> Louise Lynch, Business Administrator, presented a power point presentation of three budget proposals for the 2016-2017 budget re-vote as well as the budget revote calendar.

Several options were discussed among Administrators and Board members:

1) Scenario 1

Levy Increase Percentage 0.5861%

Total budget: \$41,522,885 Requires a 50%+1 vote to pass

2) Scenario 2

Levy Increase Percentage 1.7585%

Total budget: \$41,656,096

Requires a super majority vote (60%)

3) Scenario 3

Levy Increase Percentage 1.9869%

Total budget: \$41,656,096

Requires a super majority vote (60%)

4) Scenario 4

Contingency Budget No increase in tax levy

No extra-curricular activities

No free use of buildings for host events

No after school activities

Deborah Haab encourages community members to continue lobbying state office, by June 16th, to request release of funds that the state is holding. Further discussion took place about Scenario 1 (staying within the tax cap).

After discussion the Board agreed to propose to community Scenario 1. June 14th is the date for Budget Hearing. The June 14th Board of Education meeting will also recognize the tenure employees and retirees from the 2015-2016 school year.

Closing Comments:

- Alan Barone reminded the community that Highland Central School District has the lowest school budget in Ulster County.
- The Board thanked the staff and administrators for all their extra work with having a limited budget over the past several years.
- Encouraged the community and staff to vocalize their thoughts on the proposed budget for the 2016-2017 school year.
- Next Board meeting is scheduled May 31st at 4:30 pm.
