Property Tax Levy BOE Meeting: January 16, 2024

Overview of Tax Levy Limit Formula:

- Now in the 13th year
- Tax Base Growth Factor: <u>1.0105 is the rate for Highland 2024-2025</u>
- Payments In Lieu of Taxes (PILOT) = agreements reached between businesses and the Ulster County Industrial Development Agency to encourage development by establishing lower tax payments for fledgling businesses.
- Allowable Growth Factor = 1.02% ("tax cap" meant to mirror inflation, can follow inflation below 2% but cannot exceed 2%)
- Exclusion Amounts: Tort Judgements, Capital Levy, ERS, TRS
 - Capital levy exclusion is calculated as the amount of debt approved by the taxpayers less any state aid receivable on the debt.
 - = Tax Levy Limit
